A discussion followed regarding the cyclical revaluation and Jenn made a motion to encumber the sum of \$18,400.00 to cover the cost of the first two years of the cyclical revaluation that have been already approved and raised by taxes. Mary seconded.

There being no further business to come before the Board, Mary made a motion to adjourn, seconded by Jenn.
